## **CEO Farewell**

After 16 years as Pathway's CEO, Becky Simpson will retire on June 28, 2024. In her tenure as Pathway's leader, she guided them through the "Storm, Form, Norm" process of purchasing and moving people into new homes in 2009-10, moving administrative, DSA, and Employment teams to Medford from their long time home base of Ashland in 2012, and enhanced Employment First/Supported Employment by creating a path for high school students to enter the workforce. In 2014 she entered into a partnership with The Housing Authority of Jackson County to secure 13 apartments, an office, and two classrooms in a newly constructed 50 unit apartment building. Pathway teaches over 400 students a year at this complex, and continues to support individuals living in these apartments and in their own homes through the Supported Living program. In 2019 Becky and her leadership team made the decision to start Residential and Supported Living services in Bend, followed by Redmond. Contract services expanded throughout Jackson, then Klamath, Josephine, and Deschutes counties.

Within these 16 years, Pathway increased the number of people served who have Intellectual and Developmental Disabilities from 65 to 100+ (in addition to 400 students). Pathway also provides employment opportunities to over 60 people with other disabilities who may have barriers to typical employment. Over this time period, staff increased from 65 in 2008 to the current census of 180, and revenues from \$2.1 Million to over \$16 Million.

Becky served on multiple boards, committees, and clubs, including the State Rehabilitation Council (SRC), Oregon Council on Developmental Disabilities, Oregon Resource Association (ORA), D.I.R.T., Central Point Chamber of Commerce, and Central Point Rotary. Awards throughout her Pathway career include ranking in the top 100 Best Non Profits to Work for in Oregon each year from 2014-2023, Oregon Resource Association Leadership Excellence Award 2017, Central Point Chamber Citizen of the Year 2017, and the Central Point Chamber Large Employer of the Year 2024.

Throughout her career she embraced opportunities to promote awareness of people with disabilities and creating a standard of treating each other with dignity and respect; regardless of ability.

Crystal moved from her home in Alaska and joined Pathway in 2009 as a Residential Director. Since then, Crystal has been instrumental in creating systems to ensure Pathway's services create opportunities for people with disabilities to thrive. She has supervised Managers, Nursing, Quality Assurance, and Behavioral Professionals. She streamlined scheduling and documentation processes,

and advocated for, and on behalf of, individuals who chose Pathway services. Crystal is looking forward to Pathway's future and continuing to dedicate her life work to people with disabilities and their families.



Ali Brown serves as Pathway's COO (Chief Operating Officer), responsible for continuing policy and compliance in addition to providing Crystal with operational guidance through the transition. She ensures all departments work toward achieving agency goals. Ali has worked for Pathway since 2010, first as a Job Coach, then an Employment Manager, and as a Director since 2015. Ali guided the Community Center to flourish as one of the most successful community resources for people with disabilities. She

grew our partnerships with local high schools and continues to be a visionary for students with disabilities who want to continue learning or are finding a career path. Through the pandemic Ali recognized the need for policy and compliance oversight, as well as regulatory and contractual compliance. She supports all departments, and ensures Pathway is aligned with Oregon's rules and regulations, grant requirements, and much more.
